

Market Wrap Up

- The key equity benchmarks ended with strong gains. The Nifty closed above 22,950 mark after hitting the day's low of 22,577.45 in early trade. Trading was volatile due to the expiry of weekly index options on the NSE.
- The S&P BSE Sensex, surged 1,196.98 points or 1.61% to 75,418.04. The Nifty 50 index jumped 369.85 points or 1.64% to 22,967.65. The Sensex and Nifty clocked an all-time high of 75,499.91 and 22,993.60 respectively in late trade.
- The S&P BSE Mid-Cap index added 0.58% and the S&P BSE Small-Cap index rose 0.27%.
- On the BSE, 1,818 shares rose and 2,008 shares fell. A total of 119 shares were unchanged.
- Among the sectoral indices, the Nifty Auto index (up 2.25%), the Nifty Bank index (up 2.06%) and the Nifty Private Bank (up 2.00%) outperformed the Nifty 50 index. Meanwhile, the Nifty Healthcare index (down 0.79%) and the Nifty Pharma index (down 0.52%) underperformed the Nifty 50 index.

Corporate News

- **ITC Ltd** has reported a standalone net profit of Rs 5,020.2 crore for the March quarter, down 1.31% from the year-ago quarter. Revenue came in at Rs 17,752.87crore, rising 1.40%, the tobacco and FMCG major said in a regulatory filing on May 23. The company recommended a final dividend of Rs 7.50 per ordinary share for the financial year ending March 31, 2024.
- Sun Pharmaceutical Industries posted consolidated net sales at Rs 11,982.90 crore in March 2024 up 9.63% from Rs. 10,930.67 crore in March 2023. Net profit at Rs. 2,654.58 crore in March 2024 up 33.77% from Rs. 1,984.47 crore in March 2023.
- **Grasim Industries** posted consolidated net sales at Rs 37,727.13 crore in March 2024 up 12.75% from Rs. 33,462.14 crore in March 2023. Net profit at Rs. 1,369.82 crore in March 2024 up 0.07% from Rs. 1,368.92 crore in March 2023.
- Power Grid Corporation of India posted consolidated net sales at Rs 11,978.11 crore in March 2024 down 2.33% from Rs. 12,263.72 crore in March 2023. Net profit at Rs. 4,166.33 crore in March 2024 down 3.57% from Rs. 4,320.43 crore in March 2023.
- **Torrent Power** posted consolidated net sales at Rs 6,528.58 crore in March 2024 up 8.13% from Rs. 6,037.87 crore in March 2023. Net profit at Rs. 430.24 crore in March 2024 down 4.19% from Rs. 449.07 crore in March 2023.
- **Petronet LNG** posted consolidated net sales at Rs 13,793.16 crore in March 2024 down 0.58% from Rs. 13,873.93 crore in March 2023. Net profit at Rs. 764.43 crore in March 2024 up 23.53% from Rs. 618.80 crore in March 2023.
- **Reliance Industries Ltd.**'s Tira, a new venture in India's beauty sector, leverages AI for personalized experiences like fragrance selection and skincare analysis. - **Oil India Limited** and Numaligarh Refinery Limited signed a new long-term Definitive Agreement for the transportation of additional petroleum products through OIL's Numaligarh-Siliguri Product Pipeline (NSPL) following the commissioning of Numaligarh Refinery Expansion Project.
- **GPT Infraprojects** has been declared L1 (First Lowest) by Rail Vikas Nigam (RVNL) for an aggregate value of Rs 554.94 crore.

- **Zydus Lifesciences Ltd** has received final approval from the US health regulator to market its generic Theophylline extended-release tablets used in the treatment of asthma and chronic obstructive pulmonary disease. The approval by the US Food and Drug Administration (USFDA) is for Theophylline extended-release tablets of strengths 300 mg and 450 mg.
- **Cipla** has received approval from the US health regulator to market a generic medication used to treat acromegaly and other conditions. The company has received the final approval from the US Food and Drug Administration (USFDA) to market Lanreotide injection in multiple strengths.
- Alvotech and a subsidiary of **Dr. Reddy's Laboratories** have entered into a licence and supply agreement for the commercialisation of AVT03, the latter's biosimilar candidate to Prolia and Xgeva (denosumab). A press release from Dr Reddy's said the collaboration combines the city-based drug maker's global commercial presence with Alvotech's proven capabilities in developing biosimilars for markets worldwide.
- Strides Pharma Science said its unit has received approval from the USFDA to market a generic medication used in the treatment of gastrointestinal diseases. Singapore-based Strides Pharma Global Pte. Ltd, has received approval for the generic version of Sucralfate Oral Suspension, 1gm/10 mL, from the USFDA.

Global News

- U.S. NAR said existing home sales slumped by 1.9% to an annual rate of 4.14 million in April after tumbling by 3.7% to a revised rate of 4.22 million in March.
- U.K. S&P Global composite PMI dropped to 52.8 in May, indicating a slight decline from April's 54.1. The manufacturing PMI increased to 51.3 in May 2024, compared to 49.1 in April while the services PMI fell to 52.9 in May of 2024 from the one-year high of 55 in the earlier month.
- Eurozone HCOB composite PMI rose to 52.3 in May 2024, the highest in a year, compared to 51.7 in April. The



manufacturing PMI increased to 47.4 in May 2024, the highest in 15 months, up from 45.7 in April while the services PMI was at 53.3 in May, remaining unchanged from the near-one-year high in the previous month.

- Germany HCOB Flash composite PMI rose to 52.2 in May, the highest in a year, up from 50.6 in April. The manufacturing PMI increased to 45.4 in May 2024, the highest in four months, compared to 42.5 in April while the services PMI rose to 53.9 in May 2024, up from 53.2 in the prior month.
- France HCOB composite PMI fell to 49.1 in May 2024, down from 50.5 in the prior month. The manufacturing PMI increased to 46.7 in May 2024 from 45.3 in the previous month while the services PMI fell to 49.4 in May 2024 from 51.3 in the preceding month.
- Japan's au Jibun Bank flash composite output index hit 52.4 in May, up from 52.3 in April. The services PMI dropped to 53.6 from 54.3 in the prior month while, the manufacturing PMI rose to 50.5 in May from 49.6 in April.

Economic News

- Crude Oil traded at US\$ 78.15/bbl (IST 17:00).
- INR strengthened to Rs. 83.28 from Rs. 83.31 against each US\$ resulting in daily change of 0.04%.
- India HSBC composite PMI edged up to 61.7 in May 2024 from 61.5 in the previous month. The manufacturing PMI fell to 58.4 in May 2024, slowing from 58.8 in the previous month while the services PMI increased to 61.4 in May 2024 from 60.8 in the previous month.
- The RBI has transferred a record surplus of Rs 2.1 lakh crore to the central government for FY'2023=24 on account of windfall interest income from investment in overseas securities and income from LAF operations.
- The Reserve Bank held 827. 69 tonnes worth of gold as a part of its foreign exchange reserves as of April 26,2024, up from 805 tonnes as of end December.
- Total compensation of employees working with private corporations increased to 13.5% of the GDP in FY23 from 12.8% in the previous year while households, which largely represent the informal sector, saw their wages rise to the highest level in nine years to 8.5% of the GDP in FY23 from 8.4% in FY22.
- The Maldives said both India and China have agreed to cooperate in efforts to pay for imports in their respective countries' currency instead of the US dollar, which is likely to help Male save almost 50% of the annual USD 1.5 million imports bill from the two countries.
